However, in line with current global restrictions on every-day life and transition from the use of cheques, bondholders are encouraged to complete the afore-mentioned form and submit to the MSE at [borza@borzamalta.com.mt](mailto:borza@borzamalta.com.mt) to receive their interest electronically.

In addition, bondholders are advised that annual interest payments that fall due in 2021 and thereafter will be made electronically. Therefore, bondholders are respectfully requested to update their records in advance.
