## COMPANY ANNOUNCEMENT

The following is a Company Announcement by HSBC Bank Malta p.l.c. pursuant to the Listing Rules issued by the Listing Authority.

**Quote:**

HSBC Bank Malta p.l.c. (the "Bank") has been notified that on 1 October 2018, HSBC Holdings plc and HSBC Group Nominees UK Limited transferred the entire issued share capital in HSBC Bank plc to HSBC UK Holdings Limited. As a result of this transfer, HSBC UK Holdings Limited holds an indirect shareholding of 70.0295% in HSBC Bank Malta p.l.c, which is equal to an indirect holding of 252,320,580 voting rights in the Bank.

This transaction occurred in the context of the HSBC Group's implementation of regulatory requirements in the United Kingdom which necessitated the separation / ring-fencing of the Group's UK retail and commercial banking business from its wholesale and investment banking divisions.

The said transaction triggered the notification required by Listing Rule 5.176 (attached to this Company Announcement).

The shareholding rights of HSBC Group in the Bank are not affected by this transaction.

issued share capital in HSBC Bank plc to HSBC UK Holdings Limited. The latter entity thus became the sole shareholder and holds 100% of the voting power in HSBC Bank plc. As a result of this transfer, HSBC UK Holdings Limited holds an indirect shareholding of 70.0295% in HSBC Bank Malta p.l.c.

- in the circumstances foreseen in letter (e) of Article 10 of that Directive, the controlling natural person or legal entity and, provided it has a notification duty at an individual level under Article 9, under letters (a) to (d) of Article 10 of that Directive or under a combination of any of those situations, the controlled undertaking;
